

Now Know Ye, that the Board of Control, under the provisions of Division 1, Title 9, Chapters 10 and 14 of the Revised Statutes of Wyoming, 1899, has by an order duly made Nov 28, 1902 and entered on the 17th day of April, A. D. 1903, in Order Record No. 3, page 90, determined and established the priority and amount of such appropriation as follows: Name of Appropriator Levi Lehmer; Postoffice Address Big Piney Wyoming; General Priority Number on main stream 22; Priority Number on South Piney 1; Amount of such appropriation .72 cu. ft. per sec.; Date of Appropriation May 1882; Description of land to be irrigated and for which this appropriation is determined and established; Fifty (50) acres--Being Thirty (30) acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$ Sec. Seven (7) Twenty (20) acres in NW $\frac{1}{4}$ NW $\frac{1}{4}$ Sec. Seventeen (17) T 29 N. R. 112 W.

The right to water hereby confirmed and established is limited to irrigation and the use is restricted to the place where acquired and to the purpose for which acquired; rights for irrigation not to exceed one cubic foot per second for each seventy acres of land for which appropriation is herein determined and established.
