KNOW ALL MEN BY THESE PRESENTS, That

has located the Brett No. 16 lode mining claim, and by this certificate, and by right of discovery and location, claim 1500 feet, linear and horizontal measurement along the vein thereof, with all its dips, angles and variations as allowed by law. 1495 feet on said vein running N 88° 51' E from the center of the discovery monument and five (5) feet running S 88° 51' W from the center of the discovery monument, together with 300 feet on each side of the middle of said vein at the surface, and all veins, lodes, ledges, deposits and surface ground within the lines of said claim, situate in unorganized Mining District, County of Sublette, and State of Wyoming and described by metes and bounds as follows, to wit:

The discovery drilling has been completed at the discovery monument as prescribed by law.

The discovery work consisted of the drilling of 50 feet or more of 4 1/4 inch diameter drill hole at or near the location of the above-described discovery monument; such hole having been drilled by Teton Exploration Drilling Co., Inc., a Wyoming corporation, for the discovery of uranium and other valuable minerals.
