No. 162. LOCATION CERTIFICATE—Lode Claim. —Bradford Publishing Co., 1824-46 Stout Street, Denver, Colorado

KNOW ALL MEN BY THESE PRESENTS, That

T & T Oil Company
 ha. s. located the Pat. No. 30 lode mining claim, and by this certificate, and by right of discovery and location, claim s. 1500 feet, linear and horizontal measurement along the vein thereof, with all its dips, angles and variations as allowed by law. 1495 feet on said vein running N 88° 51' E from the center of the discovery monument and five (5) feet running S 88° 51' W from the center of the discovery monument, together with 300 feet on each side of the middle of said vein at the surface, and all veins, lodes, ledges, deposits and surface ground within the lines of said claim, situate in unorganized Mining District, County of Sublette, and State of Wyoming and described by metes and bounds as follows, to wit:
