

CERTIFICATE OF MINERAL LOCATION

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, FREDERICK,

hereby claims the land hereinafter described as a Lode Mining Claim, under and pursuant to the Laws of the United States of America and of the State of Wyoming, and, in making such claim and for the purpose of establishing his right thereto, he hereby certifies:

1. CITIZENSHIP: That He (is) (are) a citizen of the United States of America, by birth, naturalization or legal organization.

2. DISCOVERY: That on the 14 day of May, 1966, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of URANIUM and other valuable minerals, within the limits of this claim as hereinafter established.

3. NAME: The name of this claim is E - 2

4. LOCATOR: The Locator of this claim (is) (are) the undersigned, each owning an equal undivided share thereof, or the proportion after his name shown.

5. EXTENT OF CLAIM: The extent of this claim, hereby claimed by the said Locator, is as follows: From the point at which a copy of this Certificate is posted, the point of discovery, thence, in length, 300 feet in a Westerly direction and 1,500 feet in a Northerly direction, and, in width, 600 feet in a Easterly direction and 1,500 feet in a Southerly direction, comprising in all 4,500 feet in length and 600 feet in width.
