2. DISCOVERY: That on the 16 day of MAY, 1966, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of Uranium and other valuable minerals, within the limits of this claim as hereinafter established.
