1. CITIZENSHIP: That he (is) (are) a citizen of the United States of America, by birth, naturalization or legal organization.

2. DISCOVERY: That on the 14 day of May, 1966, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of Uranium and other valuable minerals, within the limits of this claim as hereinafter established.

3. NAME: The name of this claim is G-5

4. LOCATOR: The Locator of this claim (is) (are) the undersigned, each owning an equal undivided share thereof, or the proportion after his name shown.

5. EXTENT OF CLAIM: The extent of this claim, hereby claimed by the said Locator, is as follows: From the point at which a copy of this Certificate is posted, the point of discovery, thence, in length, 300 feet in a West direction and 1500 feet in a North direction, and, in width, 600 feet in a East direction and 1500 feet in a South direction, comprising in all 1500 feet in length and 600 feet in width.
