who *is* Citizen of the United States of America, by birth, naturalization or legal organization, hereby claim (s) the land hereinafter described as a Lode Mining Claim under and pursuant to the laws of the United States of America and of the State of Wyoming, and, in making such claim and for the purpose of establishing *his* right thereto, hereby certify (certifies):

THAT ON the *16* day of *May*, 19*66*, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of *uranium* and other valuable minerals, within the limits of this claim as hereinafter established.

THAT THE NAME of this claim is *G-63*

THAT THE LOCATOR of this claim (is) (are) the undersigned, each owning an equal undivided share thereof, or the proportion after his name shown.

THAT THE EXTENT of this claim is as follows: From the point at which a copy of this Certificate is posted, the point of discovery, thence, in length, *300* feet in a *West* direction and *1500* feet in a *North* direction and in width, *1500* feet in a *West* direction and *1500* feet in a *South* direction, comprising in all *1500* feet in length and *6000* feet in width.

THAT THE EXTERIOR boundaries of this location are distinctly marked by posts or monuments at each corner and its boundaries can be readily traced, viz:

BEGINNING AT *SW corner of Sec 22, T28N R103W, 2400' E + 1500' S of Sec 15-16-21-22, T28N R103W, Sec 22, 1500' E of SW corner of Sec 22, T28N R103W, 1500' S of point of origin*

TIE: Corner No. *SW corner* of this claim bears *2400' E + 1500' S* from *SW corner, Sec 22, T28N R103W* (section corner or government monument.)

THAT DISCOVERY WORK as required by law has been performed on this claim as follows:

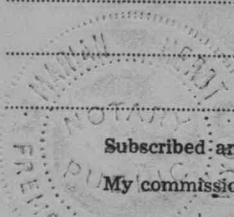
