THAT THE EXTENT of this claim is as follows: From the point at which a copy of this Certificate is posted, the point of discovery, thence, in length, 300 feet in a West direction and 1500 feet in a South direction and in width, 600 feet in a East direction and 1500 feet in a North direction, comprising in all 1500 feet in length and 600 feet in width.
