THAT ON the 17 day of May, 1966, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of Minerals and other valuable minerals, within the limits of this claim as hereinafter established.

THAT THE NAME of this claim is H-45

THAT THE EXTENT of this claim is as follows: From the point at which a copy of this Certificate is posted, the point of discovery, thence, in length, 300 feet in a Westerly direction and 1500 feet in a Southwesterly direction and in width, 600 feet in a East direction and 1500 feet in a Northwesterly direction, comprising in all 1500 feet in length and 600 feet in width.
