THAT ON the 28 day of JUNE, 1966, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of uranium and other valuable minerals, within the limits of this claim as hereinafter established.

THAT THE NAME of this claim is P.P.

THAT THE LOCATOR..... of this claim (is) (are) the undersigned, each owning an equal undivided share thereof, or the proportion after his name shown.
