THAT ON the *28* day of *June*, 19*66*, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of *uranium* and other valuable minerals, within the limits of this claim as hereinafter established.

THAT THE NAME of this claim is *911*

THAT THE LOCATOR..... of this claim (is) (are) the undersigned, each owning an equal undivided share thereof, or the proportion after his name shown.

THAT THE EXTENT of this claim is as follows: From the point at which a copy of this Certificate is posted, the point of discovery, thence, in length, *300* feet in a *Westerly* direction and *1300* feet in a *Northerly* direction and in width, *600* feet in a *Easterly* direction and *1200* feet in a *Southerly* direction, comprising in all *1200* feet in length and *600* feet in width.
