THAT ON the 2 day of SEPT., 1966 which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of URANIUM and other valuable minerals, within the limits of this claim as hereinafter established.

THAT THE LOCATOR of this claim (is) ~~XXXX~~ the undersigned, each owning an equal undivided share thereof, or the proportion after his name shown.

THAT THE EXTENT of this claim is as follows: From the point at which a copy of this Certificate is posted, the point of discovery, thence, in length, 5 feet in a WESTERLY direction and 1495 feet in a EASTERLY direction and in width, 300 feet in a SOUTHERLY direction and 300 feet in a NORTHERLY direction, comprising in all 1500 feet in length and 600 feet in width.
