Citizen of the United States of America, by birth, naturalization or legal organization, hereby claim (s) the land hereinafter described as a Lode Mining Claim under and pursuant to the laws of the United States of America and of the State of Wyoming, and, in making such claim and for the purpose of establishing HIS right thereto, hereby certify (certifies):

THAT ON the 2 day of September 1966, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of URANIUM and other valuable minerals, within the limits of this claim as hereinafter established.
