

CERTIFICATE OF MINERAL LOCATION

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, William G. King, whose address is Riverton, Wyoming, hereby claims the land hereinafter described as a Lode Mining Claim, under and pursuant to the Laws of the United States of America and of the State of Wyoming, and, in making such claim and for the purpose of establishing his right thereto, he hereby certifies:

1. CITIZENSHIP: That he (is) (are) a citizen of the United States of America, by birth, naturalization or legal organization.

2. DISCOVERY: That on the 4th day of August, 1966, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of uranium and other valuable minerals, within the limits of this claim as hereinafter established.

3. NAME: The name of this claim is Haz # 4

4. LOCATOR: The Locator of this claim (is) (are) the undersigned, each owning an equal undivided share thereof, or the proportion after his name shown.

5. EXTENT OF CLAIM: The extent of this claim, hereby claimed by the said Locator, is as follows: From the point at which a copy of this Certificate is posted, the point of discovery, thence, in length, 5 feet in a northerly direction and 1495 feet in a southerly direction, and, in width, 300 feet in a westerly direction and 300 feet in a easterly direction, comprising in all 1500 feet in length and 600 feet in width.

6. DESCRIPTION: Beginning at Corner # 1 (NW); thence 600 ft. east to corner #2 (NE); thence 750 ft. south to the east side center post; thence 750 ft. south to corner # 3 (SE); thence 600 ft. west to the SW Corner (#4); thence 750 ft. north to the west side center post; thence 750 ft. north to the point of origin (the NW Corner).

TIE: Corner No. 1 of this claim bears 1500 ft. south and 600 ft. east of the NW Sec. from corner of Sec. 3; T. 27N.; R. 103W; 6th PM (section corner or government monument.)
