## ASSIGNMENT

KNOW ALL MEN BY THESE PRESENTS that the undersigned,  
LEON PAGE FINCH, DONALD WILLIAM FINCH, CHARLES ALGURN FINCH and  
EDWIN DARWIN FINCH, d/b/a FINCH BROS. COMPANY, and the respective  
spouses of each, hereinafter called "Assignors", in consideration  
of the sum of One Dollar to them in hand paid, receipt whereof is  
hereby acknowledged, and for other valuable consideration received,  
do hereby sell, assign, transfer, convey and set over to OREGON  
SMALL BUSINESS INVESTMENT COMPANY, an Oregon Corporation, herein-  
after called "Assignee", an undivided 1/3 interest in and to all  
of Assignors' rights, titles and interest in the following:
