THAT ON the 1st day of Sept, 1967, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of Manganese and other valuable minerals, within the limits of this claim as hereinafter established.

THAT THE NAME of this claim is Map 45
