THAT ON the 1st day of Sept, 1967, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of silica, iron, and other valuable minerals, within the limits of this claim as hereinafter established.
