THAT ON the *1st* day of *Sept*, 1967, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of *Uranium* and other valuable minerals, within the limits of this claim as hereinafter established.

THAT THE NAME of this claim is *Gap 63*THAT THE LOCATOR..... of this claim (is) *(are)* the undersigned, each owning an equal undivided share thereof, or the proportion after his name shown.

THAT THE EXTENT of this claim is as follows: From the point at which a copy of this Certificate is posted, the point of discovery, thence, in length, *5* feet in a *E* direction and *1495* feet in a *West* direction and in width, *300* feet in a *N* direction and *200* feet in a *S* direction, comprising in all *1500* feet in length and *600* feet in width.
