Thence, 1500 feet in an easterly direction to the northeast corner, The point of beginning.

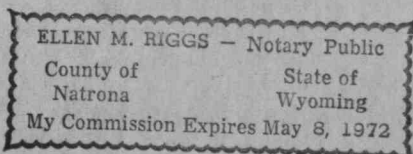
The discovery monument lies midway between the two sides and is 10 feet from the West end and 1490 feet from the East end of this Claim.
