1490 feet from the East end of this Claim.

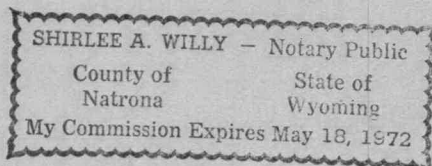
This Claim is located in NW Section 28, Township 32 North, Range 107
