1490 feet from the East end of this Claim.

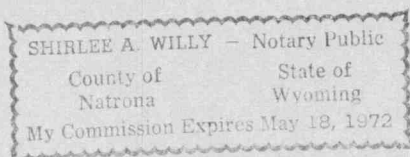
This Claim is located in NW Section 32 Township 30 North, Range 105
