To tie this Claim to the Public Survey, begin at the NW corner, Section 3 Township 29 North, Range 105 West, bear east 13,500' thence south 4200'

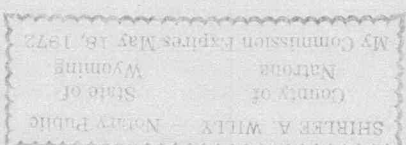
