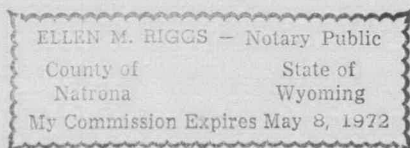
The discovery monument lies midway between the two sides and is 10 feet from the East end and
