The NAME of this Claim is GOAT 166The DATE of LOCATION of this Claim is 5th day of MAY, 19 68

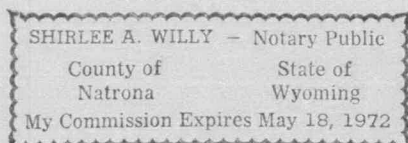
Said Claim is situated in Sublette County, State of Wyoming, and is bounded and more particularly described as follows, to wit:
