1490 feet from the West end of this Claim.

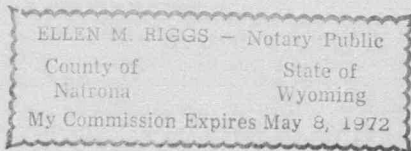
This Claim is located in NE Section 30, Township 30 North, Range 105
