The discovery monument lies midway between the two sides and is 10 feet from the East end and 1260 feet from the West end of this Claim.

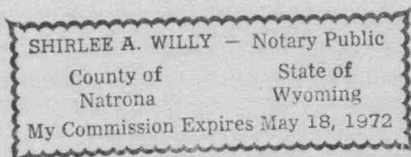
This Claim is located in SE Section 33 Township 31 North, Range 106 West, 6th P.M. Sublette County, Wyoming.
