1310 feet from the west end of this Claim.

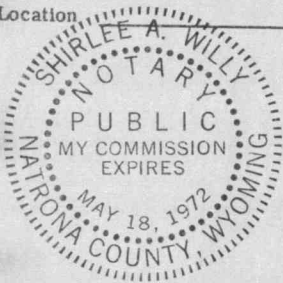
This Claim is located in SE Section 29, Township 32 North, Range 106
