The discovery monument lies midway between the two sides and is 10 feet from the East end and 1490 feet from the West end of this Claim.

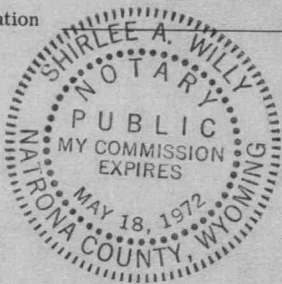
This Claim is located in SW Section 25, Township 34 North, Range 109 West, 6th P. M. Sublette County, Wyoming.
