This Claim is located in NW Section 9, Township 31 North, Range 106

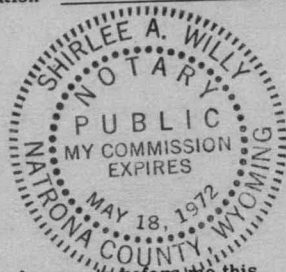
