Thence, 600 feet in an easterly direction to the northeast corner, The point of beginning.

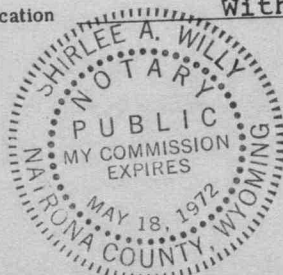
The discovery monument lies midway between the two sides and is 50 feet from the South end and 1450 feet from the North end of this Claim.
