The discovery monument lies midway between the two sides and is 515 feet from the South end and 885 feet from the North end of this Claim.

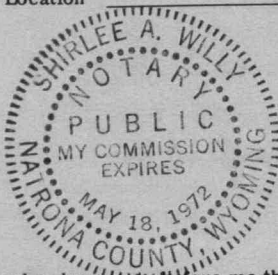
This Claim is located in SE Section 9, Township 31 North, Range 106 West, 6th P. M. Sublette County, Wyoming.
