Beginning at the northeast corner,

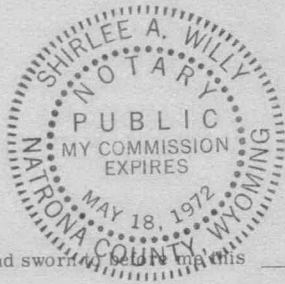
Thence, 600 feet in a southerly direction to the southeast corner,
