1490 feet from the East end of this Claim.

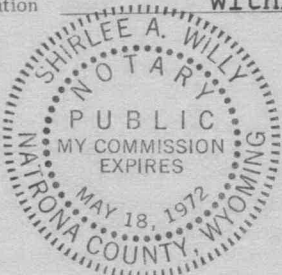
This Claim is located in SE Section 7, Township 28 North, Range 104
