The NAME of this Claim is CUB 277The DATE of LOCATION of this Claim is 14th day of June, 19 68

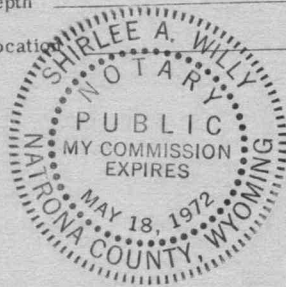
Said Claim is situated in Sublette County, State of Wyoming, and is bounded and more particularly described as follows, to wit:
