The discovery monument lies midway between the two sides and is 10 feet from the west end and 1310 feet from the east end of this Claim.

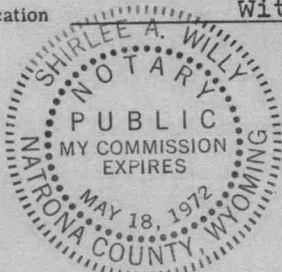
This Claim is located in SW Section 17, Township 29 North, Range 104 West, 6th P. M. Sublette County, Wyoming.
