The NAME of this Claim is DOG 54The DATE of LOCATION of this Claim is 3rd day of June, 19 68

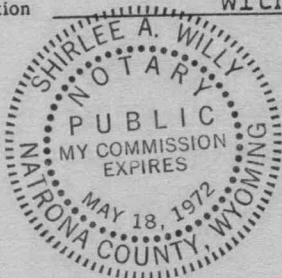
Said Claim is situated in Sublette County, State of Wyoming, and is bounded and more particularly described as follows, to wit:
