The discovery monument lies midway between the two sides and is 10 feet from the east end and 1310 feet from the west end of this Claim.

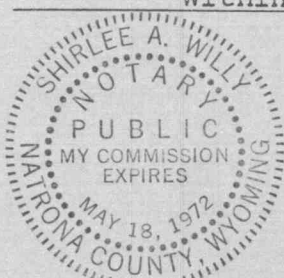
This Claim is located in SE Section 20 Township 29 North, Range 104 West, 6th P. M. Sublette County, Wyoming.
