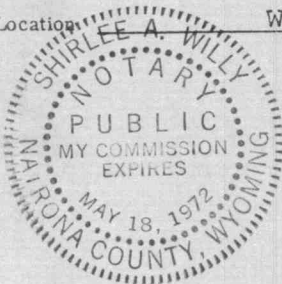
The discovery monument lies midway between the two sides and is 50 feet from the west end and
