The NAME of this Claim is GOAT 314The DATE of LOCATION of this Claim is 1st day of May, 19 68

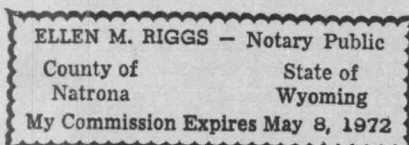
Said Claim is situated in Sublette County, State of Wyoming, and is bounded and more particularly described as follows, to wit:
