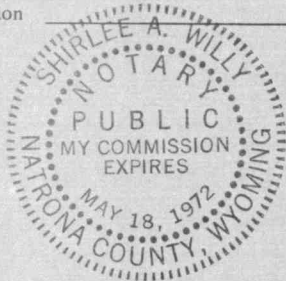
The discovery monument lies midway between the two sides and is 660 feet from the North end and 660 feet from the South end of this Claim.
