The discovery monument lies midway between the two sides and is 10 feet from the West end and 1490 feet from the East end of this Claim.

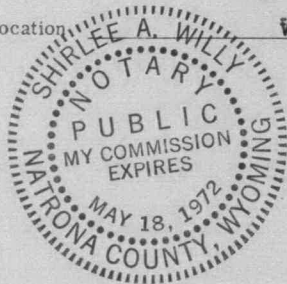
This Claim is located in SE Section 18 . Township 28 North, Range 104 West, 6th P. M. Sublette County, Wyoming.
