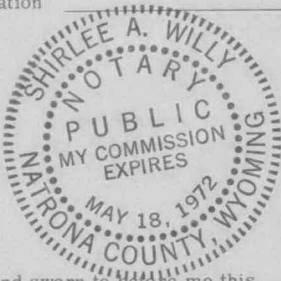
The discovery monument lies midway between the two sides and is 310 feet from the East end and 1010 feet from the West end of this Claim.
