

NOTICE AND CERTIFICATE OF LOCATION—LODE

KNOW ALL MEN BY THESE PRESENTS:

THAT the undersigned PHILLIP E. FLANAGAN, RIVERTON, WYO., who is a citizen of the United States of America by birth, naturalization, or legal organization hereby claims the land described herein as a lode mining claim, pursuant to the laws of the United States and the State of Wyoming.

THAT on the 20 day of July, 1968, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals consisting of URANIUM and other valuable minerals, within the limits of this claim as hereinafter established.

THAT the name of this claim is GREEN 993

THAT the extent of the claim is as follows:

Beginning at Corner No. 1 the NE Corner of this claim

Thence 1500'	Westerly	to Corner No. 2, the NW Corner
Thence 600'	Southerly	to Corner No. 3, the SW Corner
Thence 1500'	Easterly	to Corner No. 4, the SE Corner
Thence 600'	Northerly	to Corner No. 1, the point of beginning.

THAT the exterior boundaries thereof are distinctly marked by six substantial posts or monuments, marked on the side or sides which face in toward the claim, and are located one at each corner and one at each side center.

TIE: Corner No. 4 of this claim bears 2655' South / 150' West
 From SE Corner of Section 15 T. 27N R. 10W 6th P.M.
 (section corner or government monument)

LOCATION: This claim is located in Section 22 Township 27N Range 10W 6th P.M.
Sublette County, Wyoming.

THAT the discovery monument and notice is located on the center line 5 feet from the East end of the claim, and that the discovery work was performed on July 19, 1968 by the undersigned and is located within five feet of the discovery monument, and consists of at least fifty feet of drilling as required by law.

THAT the discovery monument is firmly fixed in the ground and extends at least thirty inches in height above the ground, and on it placed a notice stating the name of this claim, the owner thereof, and other pertinent information.

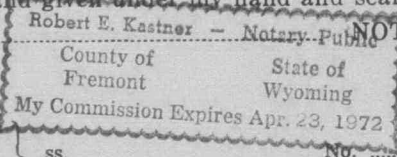
