1310 feet from the South end of this Claim.

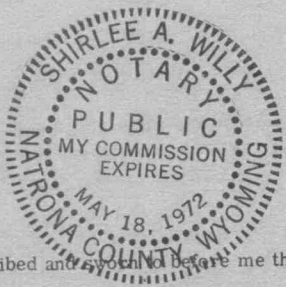
This Claim is located in NE Section 9, Township 30 North, Range 105
