The discovery monument lies midway between the two sides and is 900 feet from the West end and 600 feet from the East end of this Claim.

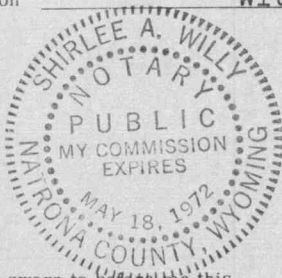
This Claim is located in NE Section 19, Township 29 North, Range 104 West, 6th P. M. Sublette County, Wyoming.
