Thence west 300 feet thence south 1500 feet thence east 600 feet thence North 1500 feet thence west 300 feet to the point of discovery.

On the surface at the point of discovery a plain notice has been posted containing the name of the lode or claim, the name *X* of the discoverer *X* and locator *X*, and the date of such discovery.
