

## NOTICE AND CERTIFICATE OF MINERAL LOCATION — LODE

KNOW ALL MEN BY THESE PRESENTS:

THAT the undersigned F. J. Mollring, who is a citizen of the United States of America by birth, naturalization, or legal organization hereby claims the land described herein as a lode mining claim, pursuant to the laws of the United States and the State of Wyoming.

THAT on the 13 day of June, 1969, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals consisting of URANIUM and other valuable minerals, within the limits of this claim as hereinafter established.

THAT the name of the claim is Bear 14<sup>th</sup>

THAT the extent of the claim is as follows:

Beginning at Corner No. 1 the SW claim corner, which lies in direction South  
1200' and in distance East 1500 feet from the SW.  
 Corner of Section 20, T. 39 N., R. 112 W of the 6th P.M.,  
 Thence E 1500 Feet to Corner No. 2  
 Thence N 600 Feet to Corner No. 3  
 Thence W 1500 Feet to Corner No. 4  
 Thence S 600 Feet to Corner No. 1 the place of beginning.


THAT this claim lies in Section 29, T. 39 N., R. 112 W, 6th P.M., Sublette County, Wyoming.

THAT the exterior boundaries thereof are distinctly marked by six substantial posts or monuments, marked on the side or sides which face in toward the claim, and are located one at each corner and one at each side center.

THAT the discovery monument and notice is located on the center line 10 feet from the East end of the claim, and that the discovery work is located within five feet of the discovery monument, and consists of at least fifty feet of drilling as required by law.

THAT the discovery monument is firmly fixed in the ground and extends at least thirty inches in height above the ground, and on it placed a notice stating the name of this claim, the owner thereof, and other pertinent information.
