

NOTICE AND CERTIFICATE OF MINERAL LOCATION — LODE

THAT the undersigned F. J. Mollring, who is a citizen of the United States of America by birth, naturalization, or legal organization hereby claims the land described herein as a lode mining claim, pursuant to the laws of the United States and the State of Wyoming.

THAT on the 7th day of June, 1969, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals consisting of URANIUM and other valuable minerals, within the limits of this claim as hereinafter established.

THAT this claim lies in Section 28, T. 39 N, R. 112 W, 6th P.M., Sub. 1/2 H.


