THAT ON the *20th* day of *JUNE*, *1969*, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of uranium and other valuable minerals, within the limits of this claim as hereinafter established.

THAT THE NAME of this claim is *MITCH # 28*

THAT THE LOCATOR..... of this claim (is) *(400)* the undersigned, each owning an equal undivided share thereof, or the proportion after his name shown.
