THAT ON the 24th day of JUNE, 1969, which date is hereby established as the date of discovery, the undersigned discovered a lode, ledge, vein or deposit of valuable minerals, consisting of uranium and other valuable minerals, within the limits of this claim as hereinafter established.

THAT THE NAME of this claim is JOHN # 28

THAT THE EXTENT of this claim is as follows: From the point at which a copy of this Certificate is posted, the point of discovery, thence, in length, 1495 feet in a Westerly direction and 5 feet in a Easterly direction and in width, 300 feet in a Northerly direction and 300 feet in a Southerly direction, comprising in all 1500 feet in length and 600 feet in width.
